- Assessment has a FAQ page
- Trying to put out communication to all
- Some schools just don't have technology
- Is the intermediate pilot on iReady done? No, there are listening sessions being conducted
- Why are we only piloting one thing?
- Major time constraint as teachers have been told to use 20% of instructional time
- 20% of normal instruction or additional
- Training = log on but no training on how to look at data, what is the purpose
- There is a PD cycle that's being rolled out, this training is how to look at data?Co
- Jan/Feb PD will be how to look at growth; where do we go from here
- Please message info out to admin and teachers purpose of trainings
- IEP use of data from iReady; guides instruction and next steps, not sure of accuracy
- Not sure if this is legal, but not on its own- needs to be use with other assessments and other data
- iReady and Smarter Balance have high correlation values so it should be valid, tentatively
- iReady not required but scores can be used as data
