 Minutes Review: A review of the last meeting minutes will be done at the next meeting. Discussion Items: Digital Citizenship by Luis Carrillo and Myles Allen A Digital Citizenship hand out distributed regarding why the district preps students and why this was brought up by Dr. Moore. It was confirmed that the badge is tied to curriculum; The group was informed about two lawsuits against the district due to the problem of students not being responsible with technology at school. There was a roll out of reasons why this is happing –some examples: cost of internet and lawsuits; CNTA asked for a percentage of students who are involved; It was confirmed that the district has 12,000.  Bring your own device (BYOD) What can they access, what if they do not have it, and what is the board policy were the questions discussed. It was confirmed that the district doesn't have an actual school capable but there is a pilot. A FAQ sheet was presented – AirWatchs, Social Media, district policy, what steps are taken if kids and parents misuse BYOD, and how teachers are protected were the questions discussed. It was noted that student's content is recorded out of context; it was confirmed that Board Policy is coming regarding technology; Teachers need to be on this committee regarding Board Policy; Teachers will not be held accountable or responsible for misuse of BYOD, abuse of recording and/or out of context material. CNTA needs to be a part of the process of developing policy from elementary to high school, including Special Education; there are many conversations regarding BYOD and the sign-up policy. - Regarding the CTE credential it is not supplemented; It equals 3 c-sets & 1 class+ 3,000 hours within industry
- It was confirmed that people with a single subject do not need this or need to manage hours; ROPC has changed funding, so many electives have been eliminated district wide.
