<u>Minutes</u>	Proposed Agenda Items
Norms-Norms were introduced by Jennifer and reviewed by the group	
Minutes Review: -No changes; A question about CMP3 and 3 year rollout was briefly discussed; It was clarified that when a change or roll out occurs it would be best to directly notify teachers and directors ahead of time to the extent possible.  Federal Program Monitoring Review by Carlos & Barbara- The FPM was reviewed; An FPM Team will be here for 2 weeks to make sure district is compliant starting 9/24-10/4/18; the team will be visiting sites; The district is currently in phase 3 of the process; The FPM is a review NOT an audit for Title I and EL review. Group went over the programs and the sites being reviewed.	
Math Adoption by Peter- The first committee meeting has been held and included 32 teachers from high school, intermediate and alternative schools. There is a timeline in place. 11 publishers have been identified for consideration. A rubric is being developed and the goals is to soon narrow down the publishers and pilot two; possibly 3 programs in January, February and March.	
ELPAC and Prop 58 by Carlos – ELPAC performance data and SBAC scores for EL students were reviewed. Reclassification cannot be done until forms are updated through DELAC which is currently in process. Prop 58 was discussed; the EDGE Initiative was passed in November 2016 and went into effect July 2017. Admin review took a years' time but there is now a Parent Language Notification, which is a notification of all parents of language acquisition programs. Site based school wide 30 students, grade level; 20 students at a site can request the language acquisition program. Required to notify all teachers, parents, and ELAC. LEA makes determination, notifies parents in writing. It is a 60-day	

process. If there is a petition it will go through process and does not mean that the program will happen, it just means the district has to consider it.

Status of NGSS and Mystery Science by Peter — Currently 770 registered for Mystery Science. About 200 used it this year. There will be NGSS trainings, which includes how to use the Mystery Science. Teachers that go to training will be able to request supplies. Site based trainings can also be conducted, principal can request. There is a document that shows where NGSS is addressed in Benchmark & Mystery Science.

<u>Current Elementary Math Pilots</u>- Two pilots with investigations at Reagan El and Todd Academy. Another supplemental program pilot with grade levels with Kathy Fauzmo – 15 schools.

Riso Concerns by Jennifer - Other options were discussed once Riso breaks down; Increase Minolta clicks; print shop.

Second and Fourth Grade Novel Survey Status by Jennifer & Barbara - Group briefly updated.

<u>Timeline of Testing</u> – Group briefly discussed if iReady and Running Records could be separated. There needs to be a brainstorm on how to schedule subs; a solution will be found for this issue.

Running Records - Group was briefly updated; email to talk about transitions.

<u>Sight Words</u>- Group briefly updated/discussed; Philip and Michelle will meet to see if committee should meet or how to transition.

SBAC/Benchmark by Jennifer — What is the district's plan in transitioning/moving from Benchmark to SBAC- IAB? Since the district is in the transition end of semester, Benchmark was not helping as much for data as sharing interim assessment block resources and finding this more helpful because of item analysis. Some schools have shown interest in using. It was clarified that teachers have to do one or the other, teachers can choose.
